The success of our Blanket order process is defined by the communication and cooperation between Fittings Unlimited INC. and the Customer that needs the inventory procured and released in a timely and professional manner.



<input type="checkbox"/>	Customer Request	<ul style="list-style-type: none"> FUI will go over the request to assess whether it is a fit for Fittings Unlimited Inc.'s Blanket Program Minimum of \$1000 per monthly release Customer's FUI account must be current
<input type="checkbox"/>	Determine SKU's for FUI	SKU's must meet the FUI Inventory model and be a reasonable request. The parts requested must meet the scope of the Fluid Power and Motion Control market. We will also need to verify that lead times are achieved to satisfy customer needs.
<input type="checkbox"/>	Verify Pricing with FUI Purchasing	FUI will need to verify pricing with our vendors to make sure that price quoted represents actual cost of current and future purchases necessary to fulfill all releases.
<input type="checkbox"/>	Create & Submit Blanket Quote	Blanket PO is entered into our system with scheduled release dates per the Customer's request. Prices on the quote are only good for 30 days. If the quote is not accepted, the SKU's will need to be requoted.
<input type="checkbox"/>	Customer Agrees to Terms and Conditions	<p>Customer must agree to and sign off on the following:</p> <ul style="list-style-type: none"> Customer must have scheduled releases: no schedule, no blanket order. Any unreleased inventory will be shipped to and the responsibility of the customer at the end of the scheduled program. Fittings Unlimited Inc. requires a minimum box quantity per SKU. Box quantities may vary. Anything under the box quantity may be reviewed but is not guaranteed. To remain in the Blanket Purchase Order Program, the Customer must keep their account current and in good standing. If the Customer account falls out of good standing, reservation of SKUs cannot be guaranteed. A Blanket Order is a contract between Fittings Unlimited Inc. and the Customer. Once placed this order is non-cancelable and non-refundable. Prices on Blanket Order items are contract prices based off the agreement and are good for only the quantities and items on Blanket Orders within agreed timeframe only. Anything beyond the agreed quantities and timeframe will require an updated quote. Any terms concerning Freight will be agreed upon before the releases. **If the Customer already has a Paid Freight agreement with FUI, that will be honored. Each release/shipment must meet minimum Paid Freight amount previously established with Customer.**
<input type="checkbox"/>	Blanket Order Created	Fittings Unlimited Inc. will process the quote into a Blanket Order with Scheduled release dates. All dates are an agreement between the Customer and FUI to be released on time and complete.
<input type="checkbox"/>	Blanket Release	Each release will come on or a minimum of 7 business days before the date agreed upon. Each release will be shipped per agreed carrier. IF the outbound freight is up to Fittings Unlimited Inc., FUI will ship on their preferred carrier.
<input type="checkbox"/>	Any unreleased inventory	If, at the end of the Blanket Program, there is any inventory that has not been released, the inventory will be packed, shipped, and invoiced to the Customer.
<input type="checkbox"/>	Request for further blankets	If the customer would like to extend, add on, or continue the Blanket Order Program, the process will start over again. Fittings Unlimited Inc. will do our best to get the pricing as close to the previous arrangement. The previous contract pricing will expire at the end of the program.
